It's that time of year again! I personally ask each and every licensed dentist within the Silver State to renew their membership in or rejoin the ADA, NDA and either the NENDS, NNDS or the SNDS. Doing what we have always done will simply get us the same results as in the past. We need new blood, new younger faces, greater diversity, and bold new ideas to break out of the same old ways of doing things. Dentists with less than 10-15 years of practice experience are the future leaders of dentistry in our state and at the national level. I urge all member dentists to volunteer at the local, state, or national level. You can join the local society's leadership team, serve on a State Council or Committee, or offer to serve at the national level. We have many experienced dentists who are willing to train you to be prepared for the challenges that lie ahead.

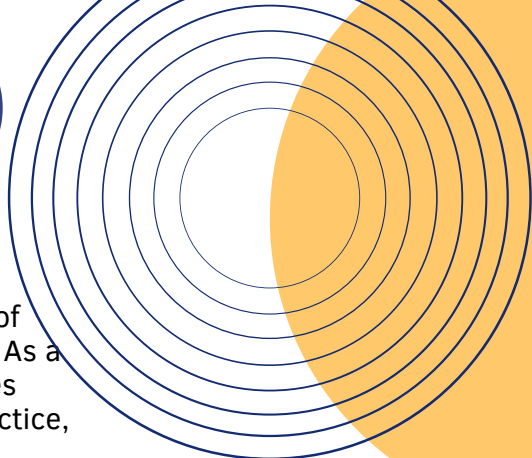

## Patients Before Profits

- **Financial Accountability:** Mandate minimum spending on patient care and quality improvements, with required remedies for non-compliance.
- **Enhanced Transparency:** Demand disclosure of financial information to demonstrate premium expenditure on patient care.
- **Regulatory Oversight:** Empower the Commissioner to review rate changes and publish compliance status.

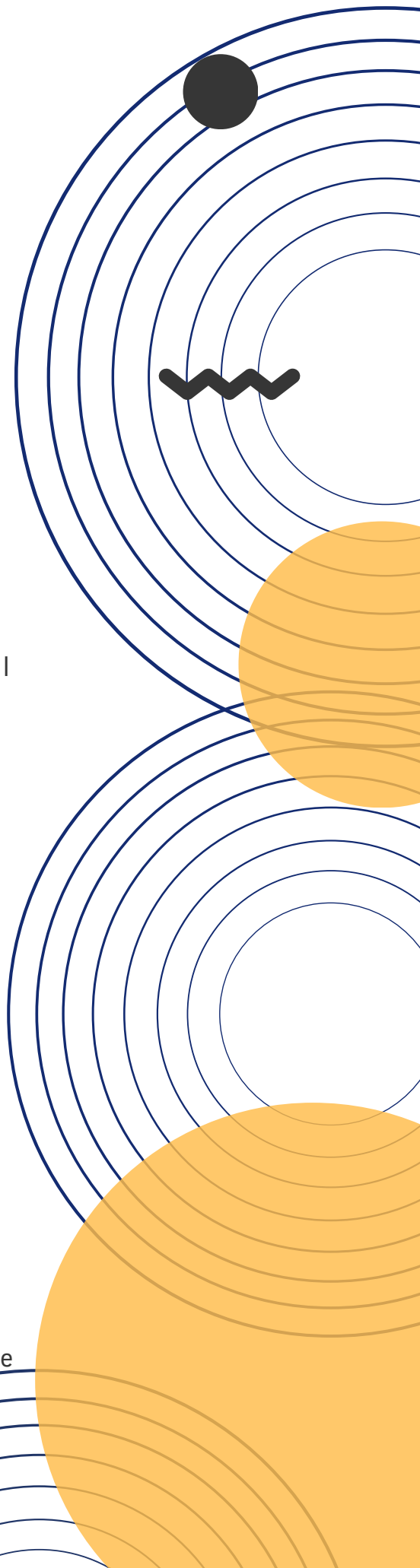
## Modernization of Dentistry

- Mandating teledentistry training for dental care providers and implementing telehealth.
- Allowing oral health providers to administer immunizations with special endorsements and establishing requirements for immunization administration by endorsed dental professionals.

## Expanded Functions

- Expands certain functions of dental assistants and hygienists to offset current workforce shortages in Nevada.

NDA is also supporting the program for repayment of healthcare student loans (including for dentists), changes to the requirements for the State Dental Health Officer, funding for the Adopt-a-Vet program, and requiring the State to pay the non-federal share of expenses for cavities, crowns, and dentures.

## **Membership DUES:**

**Tiered Dues for Graduates** – The ADA Reduced Dues Programs allow recent graduates and non-renews various campaigns as follows: The first full calendar year following dental school graduation, the dues rate is \$0; In the second year, it is 50% of full dues; Third year would then be billed at 100%; Recent graduates who enter a graduate program with the three years following dental school graduation pay the graduate rate of \$30 per year during the program and are eligible to either begin or resume the Reduced Dues Rate Program schedule upon completion.

**Reduced Dues Campaigns** – the NDA and NNDS will follow any dues pricing incentives offered by the ADA throughout the year. We also offer dues discounts for any dentist working at a federally qualified health center. Special pricing incentives will be marketed to a targeted member audience. Federally employed dentists also qualify as Direct ADA members but still are entitled to all state and local benefits.

**Networking** – of support through webinars, monthly and annual meetings to allow a member to build a community of colleagues, referrals, camaraderie, support and friends.

Peer review methods are employed to maintain standards of quality, improve performance, and provide credibility.
